

Export Compliance Certification

I understand that the part(s) and/or technology purchased from Wencor, LLC, hereinafter referred to as Wencor, or any subsidiary or affiliated company (Dixie Aerospace, Kitco Defense, Aerospace Coatings International, Absolute Aviation, Soundair Repair Group, Silver Fox Services, Accessory Technologies, Silver Wings Aerospace, Flight Line Products, Aftermarket Spares & Services, Star Aero, PHS/MWA, and Fortner Engineering & Manufacturing) are subject to the Export Administration Regulations (EAR) and/or the International Traffic in Arms Regulations (ITAR). I hereby represent and certify that the company listed below assumes responsibility for compliance to all U.S. export laws and regulations. - d. shipped or transshipped to any country currently under an embargo by a U.S. government agency (Cuba, Iran, North Korea, Sudan, Syria);
- e. used in the design, development, production, stockpiling, or use of nuclear devices, missiles, or chemical and biological weapons; or
- f. transferred or disclosed to any individual or entity identified on an U.S. government restricted party list.

Wencor will identify the export classification of our products on our commercial invoice and shipping documentation. Those items controlled by the EAR requiring a license, as well as all ITAR controlled articles, will require additional documentation prior to being released. ITAR articles require the use of an approved license or exemption prior to being exported from the United States.
